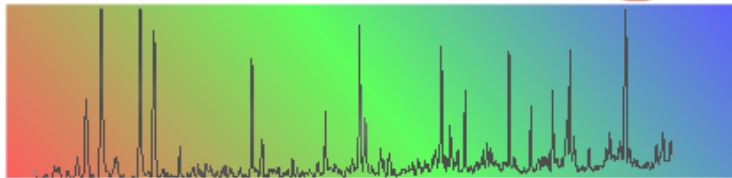

## An Introduction to Forensic Document Examination

For almost forty years, Chicago has been the home of the national forensic laboratory of the Internal Revenue Service's Criminal Investigation Division. In a newly remodeled facility just west of the Loop, close to 40 employees currently labor at examining evidence acquired during investigations of tax and financial fraud. Larry will explain the workings of the Questioned Document and Ink Chemistry units of the Lab, and demonstrate how the lab conducts examinations of handwriting, typewriting, ink entries, papers, and the output of various business machines, to attempt to determine whether fraud has occurred.

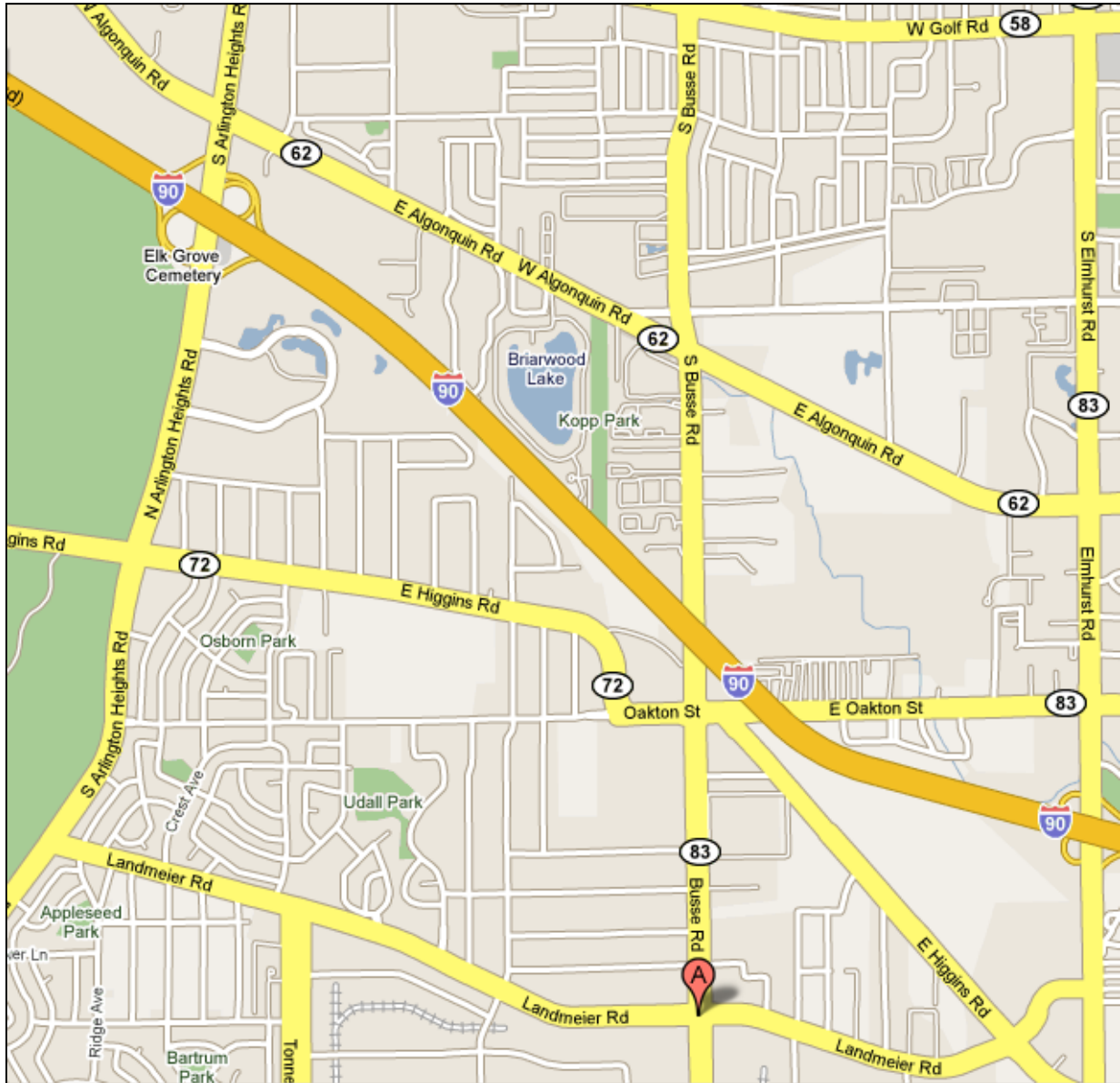
